There is also a critique of the Korean involvement in the American War in Vietnam, which was informed and shaped by Korean economy and politics in a global context. By investigating the transpacific as moments of military, cultural, and geopolitical contentions, this timely collection charts the reach and possibilities of the latest developments in the most dynamic form of transnational American studies. By identifying changing definitions of sovereignty and political space the authors highlight competing strategies of legitimising and challenging borders that have emerged as a result of geopolitical transformations of the last three decades.
